This Word sample file is an example of one-page abstract for the book of abstracts of the SURVEILLANCE7 Conference 2013 which will be held in Chartres, France, October 29-30 2013. A digital version of your manuscript abstract should be submitted online on the *Submit an Abstract* section of the conference website **before March 31, 2013**. The full conference proceedings will be only published electronically. However, a book of abstracts will be included in the conference kit and will be distributed to the participants.

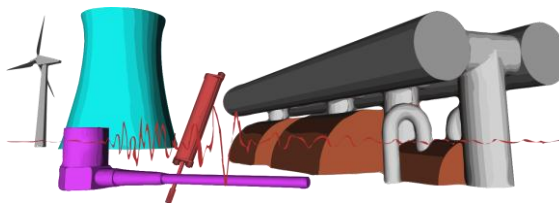


Figure 1: The logo of the SURVEILLANCE7 International Conference

Consider that this one-page abstract is a kind of advertisement for your oral or poster presentation and that the participants will see that as a selection criterion to attend your presentation rather than another during the parallel sessions. Therefore it is worth being attractive by, for example, including figures, such as Fig.1, or a few references, such as [1].

The one-page abstract should be written in English and prepared as a one-page, A4 PDF file (size 210 × 297 mm) using the Times font, 18 pt for the title, 12 pt for the authors' names and affiliations, and 11 pt for the text. The left, right, top and bottom margins should all be 1.5 cm. Please do not exceed these limits. Equations are discouraged but mathematical symbols, like $x(t)$, are tolerated. It is strongly recommended to use the LaTeX and MS Word templates provided on the conference website in order to ensure the correct formatting.

Please also note that the LaTeX template file we provide you is based on the *article* document class and, therefore, you do not need extra style files to include for the final formatting of your page abstract. All you have to do is fill the `\title{}` and `\author{}` commands as well as the main text of your abstract, and possibly add some figures and bibliography with the `\includegraphics{}` and `\bibitem{}` commands and their respective cross-references with the `\ref{}` and `\cite{}` commands. And you are done... So, please do not look for any *.sty* files, just download the *S7_abstract_latex.zip* file we provide you on the conference website, extract the *Surveillance7_one_page_abstract.tex* file, rename it, and follow the instructions above.
